**DEPARTMENT REPORTS:**

The Finance Department submitted its February, 2016 report, the Police Department submitted its January-February, 2016 report as well as its proposed Narcan Policy. Chief Aftanas explained that if the policy is adopted, each officer will carry 2 doses of Narcan and will be trained on the administration of this anti-overdose treatment. Early treatment of a heroin overdose can save a life.

## **ADMINISTRATOR'S REPORT:**

## **COMMISSIONER'S REPORTS:**

Commissioner Byrnes reported that he went to the Riverside forum on Video Gaming recently and that Commissioner Entler also attended. They went to educate themselves and found out that there is a lot of mis-information circulating. Commissioner Byrnes feels that Forest Park should hold a community forum on this subject.

Commissioner Entler thanked the public who came today and spoke their opinions about video gaming and stated that she would like to move forward with a public forum. Commissioner Entler would like staff to get started on preparations for a forum so that the Village Council can weigh their options and include the public in the process.

Mayor Calderone commended the Commissioners for raising the topic and stated that he has felt the anxiety in the community and agrees that the Village Council should stand up and get in front of it. Mayor Calderone invited the Village Council to offer up preliminary direction for staff to start working on this. The following questions/data was suggested for staff to begin with:

1. Find out what authority a non-home rule municipality has for regulating/banning exterior signage promoting VG.
2. What are the projected revenues
  - a. Gambling
  - b. Licensing
3. Suggested allocation for such revenues.
4. Crime statistics and the impact of VG on the communities that currently have VG.
5. The impact of VG on home values (if any) in communities that currently have VG.
6. Check with other Communities' Chambers of Commerce/Businesses to find out the effect of VG on those businesses who do not qualify for VG licensure.
7. Forest Park Chamber of Commerce's position on VG in Forest Park.
8. Demographics of the players who use the VG machines.

It was discussed that this would be a good start and the Village Council agreed to keep this a topic of discussion. Further it was agreed that the topic would not be on the agenda for action any time soon. Last, the clerk was instructed to provide the Village Council with the above points for their use.

Commissioner Mannix reported that with the landscaping season almost upon us, that residents who have noticed overgrown grass/weeds around town can report the address to the Department of Public Health and Safety at 708-615-6276.

Commissioner Novak thanked the public for their comments tonight and reported that ComEd has been installing the new LED alley lights and they are nice and bright.

Commission Entler reported that she has received permission from IDOT to move forward with the Community Art Project. This project is for beautification of the interior portion of the Circle Bridge. The area would be divided into sections and different groups and community organizations would create their murals. She is soliciting names to form a committee for researching the proper materials and processes to use as well as for approving artwork submissions. In addition, Forest Park will host another electronics collection for residents potentially the week of May 21<sup>st</sup>. More information will follow.

Mayor Calderone reported the following:

- The Chamber is holding their Spring Wine Walk and Shop on April 9<sup>th</sup>.
- The 22<sup>nd</sup> Annual Forest Park Pride Awards will be presented on May 4, at the Chamber's Annual Dinner, being held at McAdam Landscaping on Desplaines. Nominations are being sought.
- The West Cook Solid Waste Agency is hosting an Electronics Collection event on April 16<sup>th</sup> in Westchester. The event will take place at the Westchester Water Tower from 9:00 to 11:30 a.m. For more details contact the West Cook County Solid Waste Agency at 708-453-9115.
- Forest Park National Bank is holding a Community Shredding Event on May 7<sup>th</sup> from 8:00 a.m. to Noon. This is a free event and participants will be able to shred up to two boxes of sensitive documents. Forest Park Police will also be in attendance to answer Identity Theft and Financial Scam questions.
- Our waste hauler will begin Yard Waste pick-up on April 1<sup>st</sup>.
- The Forest Park Police will be participating in the "Cop on a Rooftop" fundraising event for the Special Olympics of Illinois on May 20<sup>th</sup> at the Dunkin' Donuts on Harlem and Circle. Those making donations will receive a free donut.

There being no further business to be addressed, Commissioner Mannix moved to adjourn into closed session to consider the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body.
