**IMPORTANT** – Only two (2) sales per year may be conducted. A double-faced sign (not exceeding six (6) sq. ft.) may be posted on the premises during the time of the sale. Personal property offered for sale may not be displayed in any front yard or any public property adjacent to the residential premises. **Signs advertising such sale may not be posted on public property or any public way. Signs posted on public property or any public way will be removed and the permit holder will be charged Twenty-Five and no/00 (\$25.00) per sign for its removal.**

Fees:    Conducted by residents of the premises	\$10.00
All other sales, i.e., estate sale, block or multi-family	\$25.00

### 3-5A-10: RESIDENTIAL (GARAGE AND YARD) SALES

- A. Defined: A residential sale includes the sale of more than five (5) items of personal property from a residential premises and includes, but is not limited to, sales designated "garage," "rummage," "estate," "yard," "lawn," "patio" "room," "attic" or "porch" sale. (Village Code § 11-267)
- B. Registration: No person shall conduct a residential sale in the village without first submitting an application for such sale with the village clerk who shall review the same and, provided the applicant qualifies under the provisions of this section, the village clerk shall issue an approved receipt.
- C. Fees: The registration fee for a residential sale shall be as set out in section [3-5-1](#) of this chapter. (Village Code § 11-268)
- D. Limitations:
1. No more than two (2) sales may be conducted by any member of a family, or an estate in any residence during any calendar year. Participation by a person or representative of an estate in any other residence sale shall be considered one sale for such participant.
  2. A residential sale shall be conducted during daylight hours and for not more than three (3) days.
  3. Personal property offered for sale may not be displayed in any front yard or any public property adjacent to the residential premises.
  4. Signs advertising such sale may not be posted on public property or any public way. Any signs posted on public property or on any public way will be removed and the permit holder will be charged twenty five dollars (\$25.00) per sign for removal. A double faced sign not exceeding six (6) square feet may be posted on the premises during the time the sale is being conducted. (Village Code § 11-269)
