The Kiwanis further would like to have the use of Veteran's Park for food vendors, etc.

Mr. Matt Brown, Scoutmaster for Forest Park Boy Scout Troup 107 expressed his support for the Kiwanis request and stated that the Troup is excited about the event and have offered to help out as a service project for the scouts.
