COMMUNITY CENTER AGREEMENTS RATIFIED The developer of the Dollar Tree Store at Roosevelt and Troost requested that Troost Avenue be made a two-way street from Roosevelt to the east-west alley. The reasoning is to allow traffic to flow to Roosevelt Road from Troost rather than from the curb cut from their parking lot onto Roosevelt. There were no objections and the issue will be referred to the Safety and Traffic Commission.
