## **ADMINISTRATOR'S REPORT:**

Mr. Gillian reported the following:

- Of the six alleys scheduled to be reconstructed, 2 are 100% completed, 2 should be open in the next week and the last should be poured in the next week or so.
- The sidewalk repair program is completed
- Madison Street construction is ahead of schedule. The paving is to be done on the Forest Park side tomorrow, the curbing on Friday and Saturday. The construction will be switched to the River Forest side in about a week.

#### **COMMISSIONER'S REPORTS:**

Commissioner Entler reported that in conjunction with World Cleanup Week in September, the village will be conducting a Free Electronics Recycling event for Forest Park residents the week of September 14 through September 19<sup>th</sup> at the Public Works Garage on 15<sup>th</sup> Street. The hours will be from 7 a.m. to 7 p.m. on Monday, September 14, from 7 a.m. to 3:30 p.m. Tuesday through Friday September 15-18 and from 7 a.m. to 3:30 p.m. on Saturday, September 19<sup>th</sup>.

- The village will be holding their 10<sup>th</sup> Annual Ribfest on Saturday, September 12<sup>th</sup> at the Picnic Grove at the Altenheim. This annual event is put together by Karen Dylewski and the entire staff at the Community Center.
- There will be a dedication/unveiling ceremony of the memorial being erected at Remembrance Park at the corner of Circle and Randolph, the site of the first Village Hall, on September 19<sup>th</sup> at 11:00 a.m. This monument is to honor three Forest Park Police Officers and one Forest Park Firefighter who lost their lives in the line of duty. The village conducted a campaign for donations to fund this project and the donations were overwhelming. The ceremony will take no longer than an hour and there will be refreshments afterwards.

- Opportunity Knocks is holding their OK Classic Softball tournament fundraising event at the softball fields at the Park District on September 26<sup>th</sup>. This is a good cause for a great local organization.
- The Forest Park Firefighters are hosting their 2<sup>nd</sup> Annual 5k Run on October 10<sup>th</sup> at 4:00 p.m. The event will be held at Concordia Cemetery and the gathering afterwards will be at the Forest Park Picnic Grove.
