Administrator Gillian reported the following:

- He is confident that the Park District, under Jackie Iovinelli's leadership will do a great job with the village's parks. From the first day of discussions, there has been a collaborative and positive attitude from all those involved. Mr. Gillian added that the parks at Circle and Lehmer were not included in the agreement because the village does not own those properties, however he will continue to try to figure out a way for the Park District to take over those parks as well.
- One employee in Village Hall has tested positive for COVID-19 and several others are awaiting results of their tests. Currently Village Hall is open to the public, however the Clerk's Office is closed at this time.

COMMISSIONER'S REPORTS:

Commissioner Byrnes expressed his gratitude to the Police Department for their efforts on Halloween, patrolling and keeping the community safe. In addition, the commissioner reported that on November 11th at 11:00 a.m. the American Legion is holding a Veteran's Memorial service at Popelka Park, recognizing veterans who gave their lives or time to make this country what it is today. All are welcome.

Commissioner Nero reported that the project on South Circle is coming to completion soon and the paving should be completed around Thanksgiving. The commissioner further added that COVID is tricky and affects different people differently and offered his well wishes and hopes for a speedy recovery to all those affected.

Commissioner Voogd echoed Commissioner Nero and wished all those suffering from COVID-19 a speedy recovery. The commissioner further reminded everyone to do their part to mitigate the spread of the virus by wearing their masks and following CDC protocols.

Mayor Hoskins reported that he is currently sick with a fever and scheduled to have a COVID-19 test on Wednesday. In the meantime, he is quarantining at home. The mayor further expressed his gratitude to the Village Council for adopting the Resolution against Antisemitism, further supporting the progressive-minded community we live in.
