A Warm Welcome To All New **Residents And Businesses**



The Cook County COVID-19 Vaccination site located in Forest Park at the Forest Park Mall in the former Hobo, 7600 W. Roosevelt Road began administering vaccines on March 25th. As of April 1st an estimated 14,000 doses were distributed. The site is open to all Illinois residents, and starting April 12th eligibility includes ages 16 and older. Forest Park residents that need assistance can contact the Mayor's office at 708-615-6203.

The Forest Park site is open Monday thru Saturday, 8:30 AM to 5:00 PM. Appointments are required. Register online at vaccine.cookcountyil.gov or call 833-308-1988 (7am-7pm). Cook County has indicated the site has administered over 31,000 doses per day. This is a partnership of Fema, IDPH and with support services provided by the Village of Forest Park. On March 25th to discuss COVID preventive measures, Mayor Hoskins joined elected officials including Illinois House Speaker Emanuel "Chris" Welch, Governor J.B. Pritzker, Cook County President Toni Preckwinkle, and Illinois Senate Majority Leader Kimberly Lightford, in addition to a number of state and local officials.

Village Reminders & Updates

Reminder: All Vehicle Stickers Are Required To Be Displayed By April 1st.

Community Center:

- Summer Clubhouse begins Monday, June 7th and runs through Friday August 13th. Clubhouse is for children ages kindergarten to fifth grade. The camp activities include swimming, field trips, structured games, creative projects and free play. The cost per week is (Resident) \$125, (Non-Resident) \$150. Space is limited. Contact the Community Center at 708-771-7737. Day Camp is licensed by DCFS.
- Door To Door Transportation is the by appointment only bus service for all Senior Citizens and Disabled residents Monday Friday. Appointments must be made at least 24 hours in advance and can be scheduled up to 6 weeks in advance. The bus is equipped with a wheelchair lift. The service area is all through Forest Park and 2 miles outside the village borders. Cost is \$1.00 each way.

Yard Waste Pickup:

- Began April 1st on Thursdays along with Garbage pickup
- Place yard waste in brown bags or in trash cans marked "Yard Waste"
- Stickers available (free) at Village Hall Clerk's Office counter
- Please refrain from raking grass clippings into the street
 this will clog sewer drains
- Brush and Branch Pickup Forestry Department picks up on Fridays
- Please place branches and brush in the parkway (between street and public sidewalk)

Police



On Tuesday, March 16, 2021, Sergeant Nicholas Defors and Officer Benito Marti were presented with the police department's "Award of Valor" at a ceremony held at Village Hall. Deputy Chief of Police Kenneth Gross, Lieutenant Chris Chin, Officers Brendan Reilly, Lauren Battistoni, Mohammad Award, Tom Cannon, Detectives Jarlath Heveran and Michael O'Connor as well as Village Administrator Tim Gillian were presented with the police department's "Award of Merit".

These awards were earned due to the actions taken on January 14, 2021 during an incident with a barricaded gunman. Officers responded to a call of a person armed with a gun. The first responding officers located the subject's vehicle and discovered that he was armed with a gun inside an apartment and threatened to shoot officers if they entered. Additional officers arrived on scene and Sergeant Defors calmly spoke with the person trying to convince him to peacefully surrender. During this two hour standoff, the subject pointed his firearm at multiple officers and eventually fired one shot in their direction. All officers worked as a team and relied on their training which ultimately brought this dangerous and tense situation to a peaceful end. The subject was taken into custody and nobody was injured.

All officers risked their own safety and should be commended for their bravery and dedication.

Award of Valor: An award granted to any member for an act of outstanding bravery or heroism by which a member has demonstrated in great degree the characteristics of selflessness, personal courage and devotion to duty.

Award of Merit: An awarded granted for outstanding police work which has brought great credit to the Department.
