REQUIREMENTS FOR RESIDENTIAL FENCE INSTALLATION

INSPECTIONS

Prior to digging any post holes, JULIE must be called at 1-800-892-0123 to assure all underground utilities are marked and avoided!

- 1. A post hole inspection is required.
- 2. The holes must be at least forty-two (42) inches deep.

PLACEMENT ON LOT

- 1. It is the homeowner's responsibility to ensure that the fence is placed within your property boundaries.
- 2. Fences must not extend beyond property lines.
- 3. Fences must not extent into the required front yard.
- 4. No fencing shall be allowed within the vision triangle at the intersection of two streets.
- 5. It is suggested that the fence sit six (6) inches inside the property boundary.

HEIGHT

- 1. Fences may not be taller than the MAXIMUM HEIGHT of six (6) feet. This is measured from the average ground level on both sides of the fence. This measurement will be verified by the Building Department.
- 2. If you have a pool in your yard, a minimum five (5) foot fence is required.

REQUIRED GATES

1. If you have a pool in your yard, a self-closing and latch gate is required.

DESIGN

- 1. The fence must be erected with the finished side out.
- The top of the fence and/or fence posts cannot have any nails, spikes or other pointed instruments of any kind topping the fence.

DECORATIVE FENCE

A decorative fence is that which is purely for decorative purposes only, and is not intended in any way to be used as an enclosure, barrier, or means of protection or confinement. No permit is required for these fences, but they must meet certain restrictions, which are not contained in this handout. Please ask for assistance at the Building Department before proceeding.

NATURAL FENCE

A natural fence is that which consists of natural growth, such as shrubs, hedges, evergreen, etc., which are thirty inches or more in height and/or spaced less than ten (10) feet apart. No permit is required for fences meeting this definition, but these fences must meet certain restrictions, which are not contained in this handout. Please ask for assistance at the Building Department.
