## **ADMINISTRATOR'S REPORT:**

Administrator Amidei reported that in addition to the official council business, there were proclamations recognizing National Police Week, National Public Works Week, National Tennis Month on tonight's agenda. In addition, the administrator recognized National Municipal Clerk's Week. The village has several full-time and part-time job openings including 2 firefighter/paramedic positions. The administrator reported that IDOT has suggested that Des Plaines Avenue paving may be completed this week and reminded residents to plan their local travel accordingly. Last, due to staffing shortages, the Village Clerk's office will be open to the public, starting on Monday, May 15<sup>th</sup>, from 1:00 to 5:00 p.m. The administrator encouraged residents to take advantage of online resources and the secure drop box outside Village Hall and thanked our customers for their patience and understanding.

## **COMMISSIONER'S REPORTS:**

Commissioner Maxham stated that it's an honor to be sitting here and thanked her family, her husband, Jason and her children Cassidy, Alex and Toby for supporting her through the election process. The commissioner also appreciates the support from the community, and Mayor Hoskins and expressed her gratitude to the village staff, department heads, and especially to the Department of Public Health and Safety Staff, Steve Glinke, Sandy Nutley and Scott Popelka.

Commissioner Nero stated that he is excited to get started and appreciates the different skills and perspectives of the elected officials, who will drive Forest Park forward.

Commissioner Melin-Rogovin stated she is excited to be here and to start learning about Streets and working with the Village Council. The commissioner is looking forward to collaborating, and hopefully writing grants to help support the village. Last, the commissioner thanked the voters who supported her efforts.

Commissioner Voogd reported on the Arbor Day celebration held last week at the library, thanking all those from the Library and District 91 who helped plan the event. The commissioner also reported that the Dog Park Ribbon Cutting event was a success, thanking the Public Works crew and Juliet Harrington for the fundraising and improvements her efforts funded. The commissioner thanked staff and retired Commissioner Byrnes for his collaboration efforts.
