ADMINISTRATOR'S REPORT:

Administrator Entler reported that our Public Works Department has had a challenging last couple of weeks, sometimes operating 24-hours a day. The administrator expressed that she received messages of gratitude from the public for specific employees and commended them for their dedication and commitment to their job. The first was Public Works employee, Joe Decosola and the second was Public Works Director Sal Stella. Next, the administrator expressed her pleasure with the teamwork demonstrated last Friday, when 8 asylum seekers were dropped off in the lobby of Village Hall, with nothing but a few personal belongings. Staff provided them with blankets, snacks and socks. Ms. Entler marveled at the kindness and dignity these people were treated with by staff in the Police, and Clerk's offices, adding how proud she was to see the care and teamwork implemented. Last, Administrator Entler reported that she has met with local government leaders regarding lead water service replacements and is meeting with the Metropolitan Mayors' Caucus in May to collaborate on storm water management and reservoir needs.

COMMISSIONER'S REPORTS:

Commissioner Maxham highlighted that two ordinances adopted this evening are examples of ways to increase revenue. In addition, staff is working on other ideas for new and amended revenues, including a places of eating tax to address a financial shortfall. Last, the commissioner congratulated Rachell Entler on her appointment as Village Administrator.

Commissioner Nero stated that he appreciates the positive vibes in the administrator's report. In addition, the Commissioner complemented Jordan Kuehn and the Safety and Traffic Commission for their presentation, adding that he would like to see some follow up on some of the recommendations. Further, the Commissioner reminded residents to be careful navigating the ice that forms after a thaw. Last, Commissioner Nero congratulated newly appointed Village Administrator, Rachell Entler.

Commissioner Melin-Rogovin joined the other commissioners in congratulating Rachell Entler on her appointment. In addition, she expressed her pride in the staff of the Public Works Department and their dedicated service to the residents of Forest Park. Next, Commissioner Melin-Rogovin expressed her gratitude to the time and energy resident volunteers provide on both the Planning and Zoning Commission as well as the Safety and Traffic Commission. The Commissioner invited the public to attend these monthly meetings. Last, Commissioner Melin-Rogovin reported that she will be attending a seminar on February 3rd,

Commissioner Voogd welcomed and thanked new Recreation Board member, Shyheim Ward for volunteering for the Board. In addition, the Commissioner expressed her gratitude to the Public Works Staff and Director Stella, and added that she really appreciated the positive and kind feedback from the residents. Last, Commissioner Voogd appreciated the Police and Fire Department staff for their dedicated service during the inclement weather.

Mayor Hoskins reported that there is a vacancy on the Library Board and asked for recommendations and applications to fill the position. Upcoming events through West Central Municipal Conference are the Legislative Breakfast on February 10 and Lobby Day on May 7. The mayor discussed the importance of attending Lobby Day and encouraged the elected officials to join him in Springfield.

ADJOURNMENT

There being no further business to be addressed, Commissioner Nero moved and Commissioner Maxham seconded to adjourn the meeting. The motion carried unanimously.
