COMMISSIONER'S REPORTS:

Commissioner Maxham reported that she attended a local tourism summit, along with Administrator Entler and Forest Park Chamber Director, Laurie Kokenes. The group is planning to promote the area and market to those attending the Democratic National Convention in Chicago in August. The commissioner expressed her gratitude to Commissioner Melin-Rogovin for hosting the International Women's Day event last week, which doubled as a fundraiser for Sarah's Inn. Commissioner Maxham further thanked all of the village's first responders, businesses, and Public Works crews for all of their hard work before, during and after the St. Patrick's Day Parade. Last, the commissioner discussed Governor Pritzker's proposal to eliminate the 1% state tax on groceries. Although the tax is only \$1.00 per \$100 spent on groceries, the Village of Forest Park will lose hundreds of thousands of dollars, which we currently use to pay for Public Works services and for our First Responders. The commissioner urged the other elected officials to join her in Springfield to lobby against eliminating the grocery tax.

Commissioner Melin-Rogovin wished all in attendance a Happy Women's History Month. The commissioner also attended a ribbon cutting ceremony for the re-opening of M.E. Marketplace. Commissioner Melin-Rogovin thanked staff, especially those who worked so hard at problem solving and coming up with a creative solution to allow all residents to enjoy the parade, even those who have sensory issues with loud noise. The commissioner further thanked the Mayor, Commissioners, Department Heads and staff who participated in the event celebrating women leaders. About 100 people attended and over \$3,000 was raised for Sarah's Inn. Last, the commissioner invited residents to participate in the Active Transportation Alliance's training for safer streets on March 12 or March 25.

Commissioner Voogd echoed the sentiments about the Parade, adding that the event was fun, the weather was perfect and the Chamber, the Police Department, Fire Department and Public Works Department staff did a great job. The commissioner additional thanked Chief Gross for coming up with the idea for the siren free/horn free zone. It was appreciated by many attendees. Commissioner Voogd expressed her gratitude to Commissioner Melin-Rogovin for her efforts, follow through and fundraising for the Women's event last Friday. The village's tree planting program will start up soon. Residents can look at the tree survey map online and determine whether their location is open for planting. There is limited availability and anyone with questions can email Commissioner Voogd or contact her through the website. Last, Commissioner Voogd asked all in attendance to save the date of Friday, April 26th for the Arbor Day Tree Planting and Saturday, April 27th for the community clean up event.

Mayor Hoskins reported that he has been in communication with Senator Harmen and Representative Welch about the Grocery Tax Repeal issue. The elimination of the tax will be a blow to this and other small communities. Mayor Hoskins urged the elected officials to join in contacting our representatives to lobby against the repeal, as well as to follow up with a written letter.
