- At least 21 years of age and under 34 years of age at time of written examination (December 18, 2025), except per Illinois Statute 65 ILCS 5/10-2.1-6. Proof of date of birth is required;
- U.S. Citizenship;
- No felony convictions;
- · High school graduate or GED equivalent;
- Possess a valid driver's license with good driving record;
- Possess a valid Paramedic License from the Illinois Department of Public Health (IDPH) (at time of offer of conditional employment; EMT-P license -OR- proof of enrollment in Paramedic program must be submitted with application);
- Present a valid CPAT card with Ladder Climb with your application with an issue date within 12 months of the date of the application deadline (December 5, 2025) -AND- CPAT card must also be valid at time of hire;
- Must successfully pass a written examination with a score of 70% or better;
- Must successfully complete an oral interview, background investigation, medical examination, drug testing, polygraph, and psychological examination;
- Submit your application by Friday, December 5, 2025;
- Participate in on-line remote testing offered between **Tuesday**, **December 16**, **2025**, **and Thursday**, **December 18**, **2025**;
- Pay a \$25.00 non-refundable application processing fee.
- Preference Points will be awarded by the Village of Forest Park and will follow the Illinois Firefighter Hiring Act.
